### INTERVIEW WITH DEPUTY JOE SULLIVAN - 12/08/2008 TRT: 11:09

- Came on shift 5:30am, left sheriff's
- Observed Red pick up run light on church
- Went through four way stop
- Drive pulled over
- Exited the vehicle reason why he ran the stop sign
- Advised to have a seat
- Heard gunshot, glass break, gun fell on him
- Called paramedics
- Came in by myself, meet him at the waffle
- Partner is Eric Purvis
- Turn sideways, and kept eye
- He got back in the seat, sitting on the edge facing the door
- He pulled up
- Total interview last 11 minutes
- At 5:34 AM, says he observes a pick up truck red light
- Says he pulls him over at Benndale Carpet
- BJJ exits truck and hands him ID and says his mother was sick
- [00:01:59] **Ofc Joe Sullivan:** At twenty six and I was 63, the vehicle stopped in the parking lot of Bendale carpet. I got out of the vehicle to talk to the driver about the violations. He exited the vehicle hands me his driver's license and advised me that the reason he ran the stop sign was because his mother was sick. I advised him to have a seat in the vehicle as a I was gonna check his driver's license. I walked back to my vehicle got down my glasses to read the driver's license and I heard gunshot and glass break. I looked up the black male fell on the ground and the gun he had in his hand fell on top of him. [00:02:34][35.5]

**NARRATIVE:** ON THE MORNING OF 120808 I DEPUTY SULLIVAN WAS TRAVELING WEST ON CHURCH STREET AT 0534 HRS I SAW A RED TRUCK RUN THE RED LIGHT AT CHURCH AND WINTER HEADED SOUTH. I TURNED MY BLUE LIGHTS THE VEHICLE THEN RAN THROUGH THE 4-WAY STOP AT WINTER AND OLD HWY-63. THE VEHICLES TAG NUMBER BJSZ PULLED INTO THE PARKING LOT OF THE BENDDALE CARPET STORE. I ADVISED DISPATCH THAT I WAS 10-39 WITH THE VEHICLE. A BLACK MALE GOT OUT OF THE VEHICLE AND ADVISED ME THAT THE REASON HE RAN THE STOP SIGN WAS THAT HE WAS ON THE WAY HOME BECAUSE HIS MOTHER WAS SICK. I ASK FOR HIS DRIVERS LICENSE AND ADVISED HIM TO HAVE A SEAT IN HIS VEHICLE WHILE I CHECK HIS LICENSE OUT. WHEN I WENT BACK TO MY VEHICLE I PICKED UP THE RADIO TO CALL IT IN AND HEARD A GUN SHOT AND GLASS BREAKING. I LOOKED UP AND THE BLACK MALE FELL ON THE GROUND AND THE GUN HE HAD IN HIS HAND FELL ON TOP OF HIM. I CALLED DISPATCH AND ADVISED THEM THAT THE SUBJECT HAD JUST SHOT HIMSELF TO SEND ME SOME HELP.
